HMART PLANS TO OPEN SUPERMARKET AT OCEANVEIW VILLAGE

Hmart, a popular upscale Korean market, has just entered into a lease agreement with Safeway-Albertsons to sub-lease the 41,000 square-foot supermarket space at OceanView Village.

Hmart is an American supermarket chain operated by the Hanahreum Group, headquartered in Lyndhurst, New Jersey. The "H" in Hmart is the initial of Han Ah Reum, which in Korean means "one full arm of groceries."

The chain began as a single store in Queens, New York in 1982. Currently there are more than 62 stores, 11 in California, along with stores in Georgia, Illinois, Maryland, Massachusetts, Michigan, New Jersey, New York, North Carolina, Pennsylvania, Texas, and Virginia. They also have stores in Vancouver, British Columbia, Toronto, Ontario, and London, England. Nine of the eleven California supermarkets are located in Southern California, with the most recent supermarket openings in San Jose, on April 5, 2017, and March 8. 2018. Expansion is planned for other Bay Area locations, including Oakland and San Francisco.

The site at OceanView Village has been closed since September, 2013 when Oceanview Supermarket, an independent Asian Supermarket, closed its doors. The lease at the site is held by Safeway-Albertsons and its parent company Cerberus Capital Management, a private equity firm, until 2027. The site was originally occupied by Albertsons, from March 19, 2002 to July 20, 2006, under a 25-year lease agreement.

The new Hmart store will offer a variety of international foods. The San Jose store features a food court with a Korean tofu house, Chinese dishes, and Japanese fusion cuisine, plus ready to cook meals to save time at home. There are fresh fish, meat, poultry, produce, and bakery departments.

On the Hmart website they state, "We've always wanted our Hmart stores to make our customers feel good about shopping there. We take pride in what our stores look like, and that also means we are meticulous about everything we offer you."

METNA will be working with the Mayor's Office of Economic and Workforce Development, and the Board of Supervisors, to expedite the permit process at the Planning Department and other City agencies, so that the new leaseholder can open at the earliest possible date to serve the community. METNA will be encouraging Hmart to offer a good percentage of jobs to a diverse neighborhood population.

311 is the central information center for the City and County of San Francisco. Providing services in over 170 languages, 24-hours a day, 7 days a week, 365 days a year, 311 is just a touch away.

Residents can call 311 anytime to reach a customer service representative, who will provide information or take a request for City government services. Calling outside of San Francisco, dial 415-701-2311 (for TTY call 415-701-2323).

Customers seeking information or help with City services can also reach out to 311 using Twitter. There is also a 311 mobile application. With the SF311 app, users can quickly and easily obtain information or report quality of life issues. Smartphone and web users can search a specialized database, designed to provide information on a wide variety of topics, including birth certificates, property tax resources, parking meter enforcement times and dates, plus many more resources.

Online information and services are also available at www.sf311.org. You can submit service requests easily, create your own personal account to view the history and status of your requests, find information on a variety of topics, view "alerts" for items that may be time sensitive or traffic impacting, plus learn about public events on the City calendar.

PEDESTRIANS GIVEN MORE TIME TO CROSS AT SIGNALS

The San Francisco Municipal Transportation Agency (SFMTA) in May stated that they will begin retiming pedestrian signals throughout San Francisco to allow more time for pedestrians to cross streets. The new timing will increase the time at each intersection from four feet per second to three feet per second to allow parents with youngsters, seniors and persons with disabilities the slower pace to cross from curb to curb.

There are currently over 1,200 street signal intersections in San Francisco. SFMTA plans to retime the signals when regular maintenance is done at each location. This new pledge is in line with the Vision Zero goal of reducing pedestrian fatalities.




SAN FRANCISCO STATE PLANS TO BREAK GROUND THIS FALL ON TWO PROJECTS

San Francisco State University will soon begin construction on two projects—a mixed-use, student housing development and a new academic building for Creative Arts.

The student housing buildings will be located on the south side of Holloway Avenue between Cardenas and Varela Avenues, one block west of $19^{\rm th}$ Avenue. The property along Holloway, formerly part of Parkmerced, is now owned by San Francisco State University. The Creative Arts Building will be located on Tapia Drive at the intersection of Holloway Avenue and Font Boulevard.

Construction on both projects will begin within the next six months with completion of both projects slated for mid-to-late 2020.

The Parkmerced Project, just south of SF State and north-east of the Merced Extension Triangle, has been delayed again. There is no new date to break ground on the 20-year build-out.

METNA REMINDER

GRAFFITI ON PROPERTY—S.F. PUBLIC WORKS CODE,

Article 23, Section 1303: Prohibition:

"It shall be unlawful for the owner of any real property within the City and County of San Francisco bearing graffiti to allow graffiti to remain." If not removed, a notice is given to the property owner to remove the graffiti within 30 days, or to request a hearing. If the graffiti has been removed, the graffiti notice is closed. If not, a second notice is sent to the property owner requesting authorization for Public Works to enter the property to remove the graffiti at the owner's expense—the greater of either \$500 or the actual abatement cost. If the property owner does not grant authorization, Public Works may seek a court order through the City Attorney to enter and abate at the property owner's expense. Public Works suggests keeping a can of your outdoor house paint color, or fence paint color, on hand in case of someone tagging your property.
