SFMTA PROPOSES BIKE SHARE STATION IN THE MET

On February 22 of this year, METNA president received an email from Adrian Leung, Bikeshare and Bike Parking Manager at SFMTA (San Francisco Municipal Transportation Agency), with a proposal to place a Bikeshare Station on the east side of St. Charles Avenue, just south of Alemany Blvd. The location happens to be adjacent to the PG&E underground gas line monitoring station and shut off valve, both on the sidewalk and in the street. The proposed Bikeshare Station would be located in the street, removing up to three parking spaces on the east side of St. Charles.

METNA officers Marc Christensen, Sue Harless, James Lee, and Claire Sanchez met with Adrian Leung at the site on March 1st. Adrian was shown and given purposes why that proposed site was not a good leasting.

March 1st. Adrian was shown and given numerous reasons why that proposed site was not a good location—adjacent to PG&E underground gas vaults, the narrowness of St. Charles, along with the 54-bus line backing up traffic at that location, PG&E underground gas vaults, the narrowness of St. Charles, along with the 54-bus line backing up traffic at that location, the removal of up to three much needed parking spaces (especially during four weekday street sweeping days, twice a month, across the street and on Alemany), plus the fact that the Alemany-St. Charles intersection is considered a high accident-injury intersection that is currently being studied by the San Francisco County Transportaiton Authority and the community working group for safety improvements within the next year. Also, SFCTA plans a Bikeshare Station two blocks to the south at the Daly City BART Station. Two alternative sites were suggested for a potential Bikeshare Station. There was also a discussion regarding the need for a Bikeshare Station in the MET. A survey was created by METNA to gauge the interest of a Bikeshare Station. Over an eleven day period, March 1 to March 11, eleven METNA members canvassed the neighborhood and OceanView Village to survey residents. 188 respondents (93 in the neighborhood and 95 at OceanView Village) filled out the survey. The survey did show interest in the Bikeshare Program and minimal interest in a Bikeshare Station in the neighborhood. METNA officers evaluated the survey results and support a Bikeshare Station, but not on the St. Charles-Alemany proposed site

Despite METNA's objections, SFMTA went ahead with their original proposal, and on March 14 posted notices at the location: "Proposed Street Changes—St. Charles Avenue at Alemany Boulevard – Bike Share Station, Establish – No Stopping, Except Bicycles; Establish Bike Share Station St. Charles, east side from 35 feet to 70 feet south of Alemany **cont'd on page4**

BROTHERHOOD WAY/ST. CHARLES AVE. SAFETY & CIRCULATION PLAN UPDATE

On March 6th, the Community Working Group on the Brotherhood Way/St. Charles Avenue Safety and Circulation Plan held their first meeting with David Long of SFCTA (San Francisco County Transportation Authority) and supporting representatives to discuss the Round One community engagement findings from the neighborhood walk-through on December 16, 2023.

Marc Christensen, representing METNA, James Lee, representing OceanView Village, and Claire Sanchez, representing the business community, are three of the eight greater area community members on

the Community Working Group.

SFCTA will be presenting three long-term concepts and then the findings from Round Two outreach will become two final alternatives, with evaluation results for the SFCTA chosen two. The key streets and intersections include, but are not limited to, Brotherhood Way at Alemany, Sagamore and Orizaba; Alemany and St. Charles; Brotherhood Way and Arch. Also in the study are Brotherhood Way-Junipero Serra (Hwy. 1) interchange, and the St. Charles Bridge over I-280, with the Belle and Niantic intersection.

SFCTA envisions "a. to improve pedestrian and bicycle connectivity and safety, including to surrounding areas, b. intersection updates to reduce driver confusion, decrease speeds, and c. preserve and improve access to the existing greenspace." The preliminary finding shows the top three challenges as: 1. Speeding vehicles, 2. Lack of safe pedestrian crossings, and 3. Poor quality or missing bike lanes. Also of high priority was 4. Traffic congestion.

A more focused on-line survey will take place in Round Two, in early summer 2024. Then by fall 2024, in Round Three, the SFCTA's plan is to "Refine two promising alternatives." By winter 2024-25 a Town Hall will take place with the "Identified Referred Alternative."



BUDGET CONCERNS MAY SCRAP NEW **CITY TRASH CANS**

San Francisco Department of Public Works (SFDPW) is in the midst of trimming its budget as San Francisco faces a looming budget deficit. Mayor London Breed has asked city departments to submit

budget reductions, up to 10% for the coming fiscal year.

As a by-product of trimming Public Work's budget for the 2024-25 year (beginning July 1), is looking at areas to reduce costs. One such area of cost savings is to reduce or eliminate the expenditure of the proposed "Slim Silhouette" trash cans which won approval by a committee and the department back in 2022. The newly designed cans do not have a firm price tag, however they have been called very expensive. The goal was to replace the current 3,000 current street

There currently are six (used to be eight) street trash receptacles in the Merced Extension Triangle, two each at the entrances to the Alemany-Brotherhood Dog Park, one on the south-west corner of Alemany and Worcester, and one on the north-west corner of Alemany and Arch. There is an additional can on the north-west corner of Brotherhood Way and Arch. That trash receptacle was moved from the Brotherhood Way entrance to Sisterhood Gardens in 2022, requested by the garden's committee due to illegal dumping at the site which now no longer occurs at that spot.

BICYCLE CURB CUT AT NORTH SIDE OF ST. CHARLES PATHWAY

Local residents and bicyclists traveling through the area on Bike Route 75 have complained for years about the lack of a curb cut for bicyclists at the north end of the St. Charles Bike Path created in 2001. That situation was rectified by Public Works with a new curb ramp added in early March.

The dead end street at the north end of the path on St. Charles had no curb cut that would be useful for not only bicyclists, but also for wheelchairs and baby strollers. Now non-motorized wheeled vehicles can traverse the ramp with ease.

BROTHERHOOD WAY GREENBELT GETS MAJOR CLEAN UP

Three Public Works crews spent January 25th and 26th cleaning up partially several hidden former encampments homeless Brotherhood Way. The BSSR crew removed tons of debris at two spots on the south side of Brotherhood, just east of Junipero Serra, while the Urban Forestry landscape crew cut brush and low hanging branches in the greenbelt. The tree maintenance crew cut and ground large low hanging and dead pine tree branches next to Junipero Serra where an abandoned encampment had been hidden.

The cleanup left the area clean and will allow the field mowers to cut grass before it grows tall and presents a fire hazard when dry. The project, requested by METNA president Marc Christensen and coordinated by Public Works Area Superintendent John Reilly, served as a beginning to a major renovation of the area in advance of the District Beautification Day on Saturday, April Volunteers worked on the Brotherhood Way Greenbelt and the Dog Park.

Bike Share cont'd from page 1 Boulevard (35 foot bikeshare station) (Supervisor District 7)." METNA contacted D7 Supervisor Myrna Melgar's office, and we received a favorable response to look at METNA's position.

A "Public Hearing" was held by SFMTA on March 22nd to hear from neighborhood residents regarding the Bikeshare Station on Many neighborhood residents emailed the SFMTA lead person to give many reasons why that location is not acceptable. Some location is not acceptable. residents also spoke on a telephone link to the meeting giving their comments.

On April 15, five METNA officers met with Adrian Leung to propose four alternate sites for a potential Bike Share Station. A consensus was that the best location would be on a concrete slab inside of the sidewalk on Alemany near Arch. Preliminary verbal approval was given to use this site by the Director of Public Works. No parking spaces would be eliminated at this location.

We wait for SFMTA's response to METNA.

LAKE MERCED WEST SHORELINE PROJECT MOVES FORWARD

The San Francisco Public Utilities Commission (SFPUC) received a Costal Zone Permit in late January of this year to demolish seven one-story recreation structures, and provide soil remediation around the former skeet shooting fields on the western shore of Lake Merced, at 520 John Muir Drive. The approximately 11-acre site was the former home of the Pacific Rod and Gun Club (PRGC) from 1934 to 2015. This part of the project "does not propose any new structures or change of use at the project site." The permit allows for soil decontamination and the demolition of seven vacant buildings that were used by the PRGC.

In 2016, the Recreation and Park Commission approved a \$2.6 million renovation of the site to become a recreation facility for water sports, for fishing, and other recreational The site now named Lake Merced West is finally moving forward after sitting idle for over eight years. The Environmental Impact Report was approved in January of 2023, under case No. 2019-014146ENV.

OCEAN BEACH CLIMATE CHANGE ADAPTATION PROJECT

The Ocean Beach Climate Change Adaptation Project is the first major climate change project in San Francisco. Part of the 2022 Ocean Beach master Plan, this new project envisions the creation of more than a mile of a new costal trail by improving access to Ocean Beach south of Sloat Boulevard.

This project is designed to protect the vital water and wastewater facility located just off Skyline Boulevard and will implement the removal of the Great Highway roadway portion between Sloat and Skyline Boulevards, followed by the introduction of a multipurpose coastal trail.

The current schedule estimates construction to begin in 2025 and take up to four years to complete. A report on this project is due out in the summer of 2024 by the National Park Service.

METNA REMINDER

NO PARKING WITHIN 20 FEET OF A CROSSWALK

Last October Gov. Gavin Newsom signed into law a parking requirement that prohibits parking within 20 feet of either side of a marked or unmarked crosswalk. The new law, known as "daylighting," provides a space for motorists to clearly see pedestrians entering a crosswalk.

San Francisco Municipal Transportation Agency (SFMTA) has begun issuing warning notices for the new parking

restriction. However, it cannot issue fines until 2025.

Note: under this new parking restriction, throughout the State of California, if the curb is painted red near a crosswalk or intersection motorists should follow that distance, even if it is less than 20 feet. However, if there is no curb paint or signage, then the 20-foot distance must be observed.

SFMTA is in the process of painting the "daylighting red zones" throughout San Francisco beginning with the city's "High Injury Network" intersections, where the most serious and fatal

traffic accidents have occurred.

ILLEGAL TO STORE OR SET OFF FIREWORKS IN SAN FRANCISCO

The San Francisco Fire Department (SFFD) and the San Francisco Police Department (SFPD) want San Francisco residents to know that it is illegal to store and/or set off fireworks on private property or public spaces within the City and County of San Francisco.

This is a serious safety issue. Fireworks at times cannot be controlled and may cause an unwanted injury to persons nearby and may cause an unwanted fire on a neighboring property. Anyone setting off any type of firework is ultimately responsible for the outcome of their actions.

Furthermore, many neighbors who have small children and pets are disturbed by the sight and sound of any type of firework. What may seem like harmless fun can have serious

SFFD and SFPD encourages residents to report anyone storing fireworks or setting off fireworks at any time. Call 9-1-1 to report any firework violations. Above all, be respectful of your neighbors and make the time leading up to the Fourth of July a safe experience for all.
